#### **Conditions of Use of ABAQUS**

The following conditions apply to the use of the computer program, ABAQUS, on any computer at the University of Manchester:

1. ABAQUS is a proprietary produce of SIMULIA (the Dassault Systèmes brand for Realistic Simulation), Rising Sun Mills, 166 Valley Street, Providence, RI 02909-2499, USA. Its use at the University of Manchester is governed by a licence agreement between SIMULIA and the University of Manchester dated 19 October 1988.
2. ABAQUS may only be accessed by members of the University of Manchester who are registered users of the University of Manchester Computational Shared Facility. Such users are required to sign the attached undertaking agreeing to abide by these conditions, before they can be granted authority to access ABAQUS by IT Services.
3. ABAQUS may only be used for the internal purposes of the University of Manchester. Such purposes shall not include commercial usage without special arrangement with IT Services. Commercial usage is defined as any use of ABAQUS for a commercial purpose or to produce calculations having commercial value, including any project or calculation of a type performed in the normal course of a non-academic business or practice.
4. Authorised users will not permit a third party to use their individual user names for the purpose of accessing ABAQUS. ABAQUS may not be copied or otherwise accessed, except as described in IT Services documentation.
5. Authorised Users agree to provide suitable acknowledgement of SIMULIA's provision of ABAQUS in all publications and reports which use results generated with ABAQUS, and agree to forward one copy of any such report or publications to IT Services, provided that such report or publication is not private.
6. Authorised Users agree that they will not use ABAQUS, directly or indirectly, in the design, development, fabrication, or testing of nuclear weapons or ballistic missiles.
